One Mega Ultimate Grand Supreme, THREE Ultimate GRAND Supremes (0-3, 4-9 & 10-up), 3 Grand Novice Titles (0-3, 4-9 & 10-up), 3 Mini Supremes (0-3, 4-9 & 10-up), 5 Overall Titles (Photogenic, Talent, Beauty, Super Model & Pink Wear), 6 Division Supremes, 6 Division Queens, Unlimited Division Princesses!

Chances are you have someone in your family or know someone that has been affected by breast cancer. All of the proceeds from this pageant will benefit the Susan G. Komen for the Cure. Our special event is pink wear. This event is anything pink and anything goes...use your imagination. Beauty dress can be any color.

Attire is Sundays Best, Pageant or Flower girl Dress. Glitz Dresses are okay. Dresses can be long or short it is your choice! Attire is not scored with the exception of the Best Dressed event. We are looking for a confident and happy child! **NO CHILD GOES HOME EMPTY HANDED; ALL WILL RECEIVE A CROWN AND A MONOGRAMMED SASH FROM MAJESTIC SASHES!** ☺ Beauty and modeling event (pink wear) is the only thing required to win division, we will take the highest pink wear score plus beauty to determine Division Supreme. The Mega Ultimate Grand Supreme will win a FREE entry into the Texas Choice Pageants State Pageant in San Antonio, TX in June 2011!!!

The highest beauty/modeling event score plus Photogenic or Talent will determine all titles. Titles will be pulled in this order: Mega Ultimate, Ultimate Grand Supremes, Novice Titles, Mini Supremes, Overall Titles, Division Supremes, Division Queens and then Division Princesses. You will receive the highest title that you qualify for. There will be no double crowning, except for the Ambassador for the Cure title.

The mini events are awarded in each division. Best Hair, Best Eyes, Best Smile, Best Dressed, Most Beautiful, Photogenic and Personality. All mini winners will receive a certificate in each age division.

Photogenic is any size photo, can be a headshot or a full body. 1 photo is included with the photogenic entry and you may add up to 2 additional photos for an additional fee. The highest scores in Photogenic, Talent, Super Model (Beauty & Pink Wear), Pink Wear and Beauty will be our Overall Winners! Grand Novice titles will go to the girl who has never won a supreme or overall title before.

Parents please have your children ready to begin at the start time. We will wait up to 2 minutes per contestant, after that time they will be moved to the end and points deducted. This helps us by keeping the competition running smoothly and ON TIME! ☺ A tentative schedule will be emailed out one week prior to the pageant.

Grand Novice Supreme – Do I Qualify???



*We have Three Grand Novice Supreme Titles:
0-3, 4-9 and 10-up*

*In order to qualify for Grand Novice you cannot have ever won a Supreme/Overall title in **any** pageant **ever**. This **includes** Division Supreme all the way up to Mega Ultimate Grand Supremes. Overall titles that are based off of modeling or face criteria are also ineligible. (ie: Overall Model, Overall Beauty, etc.) The only exception to this rule is **Photogenic** titles.*

This title was added for brand new pageant girls who just want to try a pageant for a great cause or for girls who have just never had that big win.

2. Good sportsmanship is required at all times. Bad sportsmanship will not be tolerated and is grounds for disqualification without refund.
3. We are a natural to semi-glitz system. Age appropriate make up is allowed. Small hair pieces are allowed as long as they are not distracting and look natural.
4. No flippers or full glitz hair and makeup.
5. Judges decisions are final. Please do not approach judges or tabulators until the pageant is finished.
6. Large props are not allowed for Pink Wear modeling. If you have a small prop and want to know if it is allowed just email us. We would be glad to help answer any questions.
7. Scoresheets and photos will be returned after crowning is over. Please do not discuss scores while at the venue.
8. Stage will be a T formation with three x's along the back and one in the center. Modeling can be freestyle and you are not obligated to use the x's. This venue does have a stage!!!
9. Cash only at the pageant. There are no refunds unless the pageant is cancelled and not rescheduled.
10. There is no attire score at prelims. We want happy and well put together children. Score is based off of facial beauty, personality and modeling ability for their age.
11. Contestant dressing areas are for contestants and one parent. No men allowed at any time in any dressing room.
